3314. Planning Applications

3315. Financial Update Funding requests

Clerk received an email from the Trustees asking if they could use the £1k annual funding commitment to purchase new chairs for the welfare hall as the current ones had served their time and many were in dis-repair and were becoming a Health and Safety concern. **Decision:** Following a discussion T Hardwick proposed that we agree to the £1k annual funding to be used to purchase new chairs. This was seconded by H Talaat. All Members agreed.

Clerk received a letter from Girlguiding – Grovesend Rainbows, Brownies and Guides which she read out to Members during the meeting. They have thanked us for our continued support over the last few years and expressed that our donations have made such a difference to girls in our area. However, due to the day to day living crisis they have asked if we are able to provide any further donations to go towards the rent, craft materials or trips over the next few months. **Decision:** Following a discussion and the current banking situation, S Morgan proposed that we give a financial donation of £150 and ask them to re-apply in 3 months-time once we receive the next scheduled precept payment. This was seconded by S Bates. All Members agreed.

A letter from Cerebral Palsy Cymru requesting any financial donation was read out to Members. This was noted by Members.

Training costs

Decision – All Members agreed to pay for the Biodiversity Part 1 – Module 25 training for H

Talaat, New Councillor induction training for S Bates and Chairing Skills training for T Hardwick.

Summer Fayre – 23 August 2025

Clerk gave an account of committed spend so far and gave a rundown of what was planned for the day. She advised Members that so far, she had received a financial contribution from our County Councillors, Pengelli Sports and Social, Friends of the Park and Krislyn Motors. The application submitted to COAST funding was unsuccessful but was unable to give feedback on individual applications. Further planning was ongoing and she was grateful for the help from representatives from Friends of the Park and Pengelli Sports and Social towards the planning.

3316. Assessment of biodiversity actions (Section 6)

We have to completion and publish a Section 6 report by the end of 2025. L Holloway has attended some training and H Talaat is due to attend in the next couple of weeks. Clerk presented Members with our previous report for discussion.

3317. Clerk's Report

The Clerk reported on the following: -

- (ii) Training Updates: -
 - H Talaat will be attending Biodiversity Training on 7 August.
 - S Bates will be attending the New Councillors Induction training on 21 July.
 - T Hardwick will be attending Chairing Skills training on 5 August.
 - She reminded Members of the free webinar training places available
- (iii) Child Poverty Strategy for Wales Lived Experience Engagement Exercise are offering short-term grant funding to support organisations in engagement with people with lived experience of poverty in Wales. Deadline for completing application is 11 July.
- (iv) A draft version of the Planning (Wales) Bill and supporting draft Explanatory Notes has been published.
- (v) The Standards Committee of Swansea Council is seeking applications from Community / Town Councillors within the Swansea area to sit as the Community / Town Councillor representative on the Committee. Applications to be submitted no later than noon on 25 July 2025. W Erasmus has expressed an interest in applying for the position.
- (vi) She advised Members that she had sent our condolences to the family of John Millard, Clerk to Gorseinon Council who had sadly passed away.

3318. Health and Safety

- (i) Members felt the path on Coalbrook Road was a Health and Safety issue. Already discussed actions above.
- (ii) S Bates informed Members that there has been a loose grate outside 105 Coalbrook Road which keeps getting moved leaving a big hole. He advised that it has been like this for weeks now. **Action:** Clerk to report this to Highways.
- (iii) On behalf of a resident M Jones brought up the old shop at 1 Station Road to the attention of the Members and the state of the shop front and broken glass. **Action:** Clerk to report to the enforcement department as a health and safety matter.

3319. Any other business at the discretion of the Chair

- (i) Garden Competition Clerk informed Members that she had only received a few entries for this year's Garden Competition but Members felt that we should still continue with the competition and maybe do a leaflet drop next year. **Action:** Clerk to contact judge to arrange a judging date and inform all entries of this date.
- (ii) H Talaat informed Members that Pengelli Primary School were looking at opening a shop

next year under the sustainability project and would be selling things like washing powder, etc (long lasting goods). This would obviously cost to set up and was wondering if this was something that the Community Council would support if the Eco-committee were to submit their business plan to a future meeting. **Decision:** Members initial thoughts were that this was a good idea and would be interested to hear more about it. **Action:** Clerk to invite the school committee to a future meeting to present their business plan.
